code::dive conference is for professionals and professional conduct is expected of all attendees.

§1. The common rules of the contest

The code::dive conference, which is described in the following regulation (hereinafter referred to as Conference), is related to natural persons (hereinafter referred to as Participants).

The conference will take place on the 14th – 15th of November 2017 in Wrocław. The conference place is: Kino Nowe Horyzonty at Kazimierza Wielkiego 19a-21.

§2. Contest organizer

The organizer of the contest is Nokia Solutions and Networks Sp. z o.o. placed in Warszawa, Domaniewska str. 39A, entry into the register of business entities KRS 0000265262 (hereinafter referred to as Organizer).

§3. Conditions of participation in the Conference

Every person registered online via the codedive.pl webpage, and received the event invitation participate in the Conference. Due to the seats number limitations, not all registered Participants will receive the event invitation.

Conference is none profit event and participation in the Conference is free of charge.

Organizer's employees, including subcontractors, mandators, temporary employees, and other coworkers of the Organizer can participate in the Conference under special conditions, which will be distributed internally in the company.

§4. Organizational aspects

Before entering the Conference hall, the Participant must put the identity card in visible place. Identity cards will be available in the special Participant registration place.

§5. Security

§6. Other regulations

Organizer will record and take photographs during the conference.

The above regulations are valid in case the Participant will be recorded or photographed during the Conference, or when the Participant would voluntarily agree to an interview in front of the camera or posing for pictures.

Advertising other brand than Nokia is absolutely forbidden during the Conference, unless prior permission has been obtained. Those who will break the rule will be asked to leave the Conference.
